Unavailability: If Indigo's facilities are substantially unavailable for sue due to damage or loss for any reason, Member's membership Term will be extended for a period of time equal to the time of loss or unavailability. 9. Liability Waiver and Release: Member agrees to complete and abide by the attached Liability Waiver and Release.
- 10. Classes/Content: Scheduling and content of the classes offered at Indigo, as well as the facilities and instructors, is at the sole discretion of Indigo and may change from time-to-time upon notice by Indigo. Indigo agrees at all times to provide qualified instructors to teach and supervise classes. Member also agrees that during the course of instruction, Indigo instructors may engage in physical contact with the Member for the purposes of skilled adjustments. Members may elect not to receive adjustments by verbally notifying the instructors.
- 11. Holidays: Member understands that the facility may not be open on national or local holidays at Indigo's discretion.
- 12. Compliance with Ohio Law: This Agreement shall be governed by Ohio law. All rights and obligations of the parties are also subject to applicable federal, state and local laws and regulations. If any portion of this Agreement shall be deemed unenforceable, the remaining portions shall continue in full force and effect. This Agreement represents the entire Agreement of the parties and incorporates the attached Liability Waiver and Release.
- 13. Membership: Member agrees to faithfully comply with the terms of this Agreement as well as the rules and regulations of Indigo and above all to practice safely and mindfully. Indigo reserves the right to suspend or terminate a member, who does not observe studio rules or who poses a threat of harm to him or herself or others. In that unlikely event, the Member will not be entitled to refund for tuition during the cancellation notice period.
